DISCLAIMERS

Permits are required for all ballfield use.

Permit holders may only use ballfields during the specific dates and times listed on their permits. Entering a field before the permitted time or participating in batting practice is strictly prohibited.

Permit holders must clean up after each game and carry all collected garbage, including ice, out of the park.

Football, soccer and rugby are prohibited on the Great Lawn fields all year and the North Meadow fields during the spring/summer season.

Touch football is allowed on the North Meadow fields during the fall season with a permit.

Youth soccer is allowed on Great Lawn fields 7 and 8 during the fall season with a permit.

Vehicles are prohibited; all materials must be carried in and out of the park.

Cleats are prohibited.

Alcohol and barbeques are prohibited.

Bicycles and roller blades are prohibited.

Dogs are prohibited on ballfields.

Picnics are prohibited on ballfields. Picnics are allowed in designated picnic areas with a permit.

Field maintenance is restricted to Central Park Conservancy staff. Permit holders may not engage in field maintenance or interfere with the use of any equipment at any time.

Ballfields are closed regularly for maintenance or due to weather conditions. In these cases, red flags are displayed to indicate ballfield closures. If red flags are present, any ballfield use is strictly prohibited.

Permit holders are encouraged to frequently call the ballfield hotline to check the availability/conditions of the fields. Please call 212.628.1036 ext. 806 for the Great Lawn or ext. 808 for the North Meadow.
